

Neighborhood Conflict Resolution Service

MCA has constituted a resolution conflict mediation process specifically to assist neighbors who have not been able to settle disagreements growing out of one or both neighbor's rebuilding plans, post Jesusita Fire. The service is completely voluntary; both parties need to agree to participate; and the results are non-binding. We hope that we can help resolve these conflicts quickly.

In order to participate, one of the neighbors should initiate a request to the conflict resolution committee of MCA.

Please provide your names, address, all your telephone numbers, and email address. Please provide at a minimum the name and email for your neighbor, and we'll get the rest of the identifying data from them, about them.

We'll provide you and your neighbor with a set of written questions (attached) and a deadline, and a proposed date for the Conflict Resolution meeting. The one-time meeting will last up to one hour, and will occur at the McViegh House (back of Museum of Natural History complex).

Please answer the following questions. <u>Limit yourself to a maximum one typed page for the complete set of written answers</u>, 10 font minimum. (We'll also just read the first page if you go over). You may, and are encouraged, to also submit up to 5 photos, and 3 architectural drawings. No witnesses can be brought into the session, just the homeowners in conflict.

We will also ask you to sign an agreement prior to beginning the mediation process that in the event that you and your neighbor are unable to resolve the conflict, that the mediation service is confidential, and that you will not subpoena, nor ask a court to subpoena the MCA conflict resolution team or documents submitted to us.
