3. Treasurer's report approved (Erika)

We started with \$38,407 and ended with \$46,577. Received \$910 in donations and \$10,030 from closing a bank CD. Expenditures were \$2,771 (amounts rounded to whole dollars).

4.1 Museum of Natural History update (Luke)

4.2 Botanic Garden update (Steve)

The Garden was deemed an "essential service" and therefore able to remain open to the public. Attendance has been strong but still below CUP limits. The neighbor gates are open to members wearing masks. The Garden received a \$250K grant to remove invasive species from "ridge to ridge," including areas of private lands. The goal is to get invasive species completely out of the watershed. The first-year effort will focus on completing an assessment. The project covers a 5 year period.

A shaded oak fuel break project in the upper portions of the Garden was never funded but is still being worked on.

4.4 Historic Bridge/Mission Heritage Trail Association (Ericka)

More than 50 members of the public participated in the December 2 webinar sponsored by the City. The group presented three bridge and roadway/pathway options. The MHTA board endorsed #3 which expands the bridge as a single arch to 50" with sewer lines included, and #A which widens the roadway and bridge equally on both sides to increase driver sight distance, add bike lanes, and pathways on both sides. Next steps is

to meet with the California Office of Historic Preservation. A Concept Review with the City's Historic Landmarks Commission will follow during the 1Q 2021.
