 - 200 members in coalition
 - Francesca had a petition against rebuilding the bridge, so far 700 people have signed (150 from Mission Canyon)
 - No mention of disturbing bridge in initial talks
 - City's 3 proposals talked about replacing the bridge
 - The Coalition says the existing bridge is safe and that the current configuration slows down traffic
 - Many arguments against the project
 - No difference between the old and new bridge in width
 - They would like Mission Canyon Association to back them
 - Comments by other people
 - Erika Sharghi, (speaking for Heritage Trail Assoc.), No intent to destroy the bridge but to update it as it was done in 1930
