3. County Update: Kadie McShirley (on behalf of Supervisor Das Williams) via email "SCE upgraded some poles on Exeter Place and Cheltenham I believe. I heard from four different Mission Canyon folks about this. Reached out to SCE and received the following message:

This work is related to the Modoc Substation elimination project. When speaking with the project general supervisor last week, he shared that due to the fact this is a high fire area and our wildfire mitigation efforts, a covered conductor was installed, also known as coated wire, and additional protective covers, thus it may be more noticeable to customers than the previous wire/equipment. The pole heights on some of the replacements also needed to be increased to gain appropriate clearances between conductors. Unfortunately, those pole heights cannot be reduced.

Although it doesn't sound promising, I am doing a site visit tomorrow at Mr. Weed's property and hopefully getting someone from SCE there.

Luke's email on the collision incidents at the turn near Museum of Natural History – I've shared it with Public Works to see what ideas they might have.

In terms of the parking on Tunnel Rd, let me know how the discussion goes and I

can check in with Public Works. They can even likely attend the December MCA meeting to discuss this topic?"

- 4. Museum of Natural History Update: Amy Carpenter
 - They are up to 5 days per week with school kids.
 - Roof repair on the library is almost complete
 - New poles have been installed in the parking lot, waiting for the light fixtures. These are compliant with dark night skies.
 - No Tribal Arts Show this year.
 - There will be smaller "trunk sales" in the Museum shop this year.
- 5. Botanic Garden Update: Keith Nevison
 - Just had Fall Plant Sale kick-off to members on friday
 - There is time ticketing so the parking does not start to overflow
 - The sale has been great.
 - They did roadside trimming on Tunnel and Mission Canyon Rd.
 - Some of the neighbors wanted them to do some screening so they are going to install some native chaparral shrubs (ex. At 1140 tunnel road house burned in the fire) this way you will not see the mulch pile.
 - They finished installing the gate card-reader for the back gate. They are testing it now. They need to find a way to update the roster in a timely fashion so that the membership will be current and let the correct people in. Hope to work this out by the end of November.
 - On Tipton Trail (new 1 mile trail that starts at the Conservation Center and goes down and crosses an unnamed tributary creek to rattlesnake) getting a grading permit. CDFW has already granted the permit for the bridge over the seasonalcreek.
 - They are working with Fehr & Peers to decide how they would like to update the parking lot. To do this they will need an updated traffic study.
 - They are also working on finding a way to extend the Garden out into the community. Ex: doing this with Alice Keck-Park Park
